

4-H JUNIOR FAIR BOARD APPLICATION REQUIREMENTS

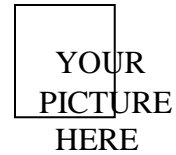
Applicants are to be 15 as of January 1, 2019, or a sophomore in high school and an active member of 4-H.
