Dicamba Soybeans Sprayer Education

A couple weeks ago or so, I wrote about some of the changes that were coming with the technology of Dicamba resistant soybeans. There were several that used this technology in 2017 and will probably be many more in 2018. There were several issues that occurred with neighbor soybeans and the reasons could be several things, but in the end neighbor soybeans were damaged in some cases. This does not typically set up the best situation when crops are damaged so there will be more education required to use this technology in 2018.

From what I understand, there will be training offered by the companies that supply the technology. What I have been told is that OSU Extension will NOT be doing the training. The requirements for applicators will be different than what is the norm for those using restricted pesticides.

In the case of Dicamba the applicator will have to be trained. The actual person doing the application, not someone that is supervised by someone who has been trained.

This was not the only thing that I took away from the training that I attended last week about Dicamba and what happened in 2017. Farmers in many cases are good neighbors to each other. In most cases, when something goes wrong that causes damage to a neighbor crop, it is simply taken care of and compensation is made amongst themselves. No need for anyone else to be involved. No need to cause someone to get in trouble if they can work it out, everyone is happy in the end, or at least satisfied.

The message that I heard on the issues with Dicamba in 2017 included cases where this happened. The message that ODA (Ohio Department of Agriculture) shared with us was that they need documentation when there are problems with this technology and other's crops are damaged. What I understood was that ODA was not looking to levy fines, but needed documentation of issues so they could better deal with the problems that occur. My understanding is that they need to know about the problems. The number of problems that I heard about here locally compared to the number of reported to ODA for the entire state of Ohio makes it clear that most issues were not actually reported to ODA in 2017.

Pesticide and Fertilizer Re-certifications for 2018

The dates for the 2018 Pesticide and Fertilizer re-certifications are listed below in the Dates to Remember, however I have not discussed the registration for this year. As I told a few weeks ago, the plan is to have 2 new educators hired soon. I will soon be covering just Adams County and the two new hires will be for Brown and Highland Counties. So all registrations will NOT be in Brown County with Cindy as it has been the past several years. Yes, you can still attend any of the sessions, but you will need to register for the one you plan to attend. There are other changes to registration coming this year, too.
