## **Estate Planning**

Multiple children and one child is involved in the farming business, so naturally that child may be left the farm while the other children may be set to receive the house or other property or money. What happens if there is an extended stay in a health care facility that pretty much consumes all of the life savings (money) that was to be left to one or more of the children to offset the value of the farm or business?

On the other hand you are leaving the farm or business to the child involved in the business and you have already put the farm or business in his or her name so it is protected in case something happens to you. The child married a great man or woman that is part of the family, however as time goes on they are not the happy couple they once were. They end up splitting up and they are headed to court to settle the divorce. OH MY, the farm or business is part of the settlement because it has been transferred into the child's name even though it is still your business.

OK, you know that will not happen. They will be happily married forever. So that previous scenario does not fit your situation. What happens if either your child or their spouse is involved in a car accident or develops a health condition that will require long term health care (which isn't cheap) and the funds eventually run out? This could put the farm or business in the same risk that you were trying to avoid with your own possibility of long term health care expenses.

The situations can go on and on. The idea that you and the people who help you set up your estate plan need to be on your A game may be an understatement. There are lots of things that need to be considered. In addition to getting your estate plan set up, it may be like buying a new car. Once you have bought the car or set up your estate plan you are all done, right? You have to do maintenance like changing the oil in the car and grease it from time to time. You might want to schedule routine checkups for your estate plan, too. Things change, your assets may increase or decrease, your family situation may change like it did in one of the examples above, you may have taken out more long term health care or life insurance.
