Additional Winter Meeting Dates

As I typed that title it seems crazy that we already have snow on the ground. Many area farmers are nowhere near finished with harvest. In addition to the Farm Bill Meetings that I listed last week, and appear later in today's column, I have dates for a Forage School, a Beef School, Pesticide Re-certification/Fertilizer Certification, and GAP (Good Agricultural Practices) for tobacco producers.

I do not have locations finalized for the Forage or Beef Schools, but do have the dates and times. The Forage School will be held on Wednesdays in January at 12:30 p.m. The dates are January 7, 14, 21, and 28 and the program is scheduled for 3 hours each day. The cost for the Forage School is \$30. Please call Tami to preregister for this program at 393-1918.

The Beef School is scheduled for Tuesday nights. The 3 dates are January 27, February 10 and February 24. The location is still in the works. I hope to have the topics for each night in the next week or two. The start time is 7:00 p.m. for each night.

Now for the Pesticide Re-certification and Fertilizer Certification dates and the explanation of who needs to attend which of the following sessions. For those who have a private applicator license for pesticides, if you need to obtain a Fertilizer Certification, you will need to attend a 2 hour session. The Pesticide and Fertilizer will be offered in each of the three counties. They will be offered so you can attend both sessions the same day, or evening. For those who do not have a pesticide license, but need a Fertilizer Certification, you will need to attend a 3 hour session. These dates will be offered in March after we get the Pesticide/Fertilizer sessions completed. If you questions about the Fertilizer Certification you need to contact the Ohio Department of Agriculture at 800-282-1955. We have materials at the OSU Extension Offices and I have placed them around the area in Farm Supply stores, Stockyards, Barber Shops and other businesses. I can also e-mail one to you if you want. Pre-registration is REQUIRED for these programs and the fees need to be paid at least 5 days prior to the date of the class. Cindy in the Brown Co. Office will do all pre-registrations for Pesticide Re-cert and Fertilizer Certification. Call Cindy at 378-6716.

The dates are: Wednesday, January 21 at North Adams HS beginning with the Fertilizer Certification at 4:00 p.m. and the Pesticide Re-certification begins at 6:00 p.m. with a light meal; Thursday, Feb. 5 at the Southern Hills Career Center Board Office in Georgetown on Hamer Road. The program will start at 11:30 a.m. with lunch and the fertilizer section followed by the pesticide re-cert; the final date will be in Hillsboro at Southern State Community College beginning at 11:00 a.m. for the Fertilizer Certification and lunch, followed by the Pesticide Re-certification. Applications Available For Educational Excellence Grant

The Southern Ohio Ag and Community Development Foundation has made the applications available for the \$7,500 Educational Excellence Grant for 2015-16 year. The applications are available at FSA and OSU Extension offices, or you can go online to www.soacdf.net and print one. This is directly from the application as far as who is eligible.

Individuals who have a current Farm Service Number on record with the Farm Service Agency at the time of application submission and reside in the 22 counties the Foundation serves OR tobacco quota owners, quota owners/growers, or grower/tenants of Farm Service Agency record in any single crop year from 1997 through 2004, and their immediate family dependents, that are enrolled at an accredited institution and are seeking a Bachelor degree are eligible. Applicants must be enrolled as a **full time** sophomore, junior or senior in the 2015-2016 school year to be eligible.
